CARGO LOSS MINIMISATION STUDIES

Reducing over the road cargo losses can be a daunting task. The leading causes of loss or damage to goods in transit are besides collision, rollovers, jerks & jolts, theft, pilferage & spoilage. Another common cause is the result of improper cargo handling. Carriers should have processes to monitor and evaluate loading and unloading practices. Policies should also be in place to ensure that adequate blocking, cleats, braces, straps, load bars, separators, fill material, and locking devices are used. Drivers should be trained to identify any visible damage and properly notifying their findings.



FLEET AUDITS





Vehicles in good condition don't just mean a good brand image, but also play a critical role in ensuring the safety of your goods and people. Warehouse capacity calculator is a tool designed for calculating the safe storage capacity of the warehouse taking into account the mix of products handled. The calculation will be done in line with relevant national / international standards and applicable safety regulations.

Proper aisle sizes for FLT movement, clear segregated man machine movement aisle, clear layout and plan for loading, unloading bays, storage space identified and segregated as per relevant national & international safety standards, building code, outside parking areas. The program is designed to engage the drivers' hearts & minds through innovative teaching practices and inculcate in them the right skills, attitudes and behaviour.
